This document details Geist's corporate policy regarding the use of conflict minerals. The policy expressed in this document should be considered to cover the Geist and Geist Europe divisions of PCF Inc.

Section 1502 of the Dodd-Frank Act which was passed by the US Congress in 2010 requires certain companies to annually disclose their use of conflict minerals. Conflict minerals covered under this act include tantalum, tin, tungsten, and gold.

Although Geist is not directly subjected to the requirements of the Dodd-Frank Act, Geist recognizes that all companies within the electronics manufacturing industry supply chain are impacted by this legislation. Geist supports the intent of the law, which is the reduction of violence within the Democratic Republic of the Congo and will take several actions to both advance the goals of the Dodd-Frank Act and to provide exceptional support to our customers.

- Geist will work with our direct suppliers to identify purchased components and materials that contain tin, tantalum, tungsten or gold.
- Geist will work with our direct suppliers to trace sources of any tin, tantalum, tungsten or gold used in our products back to the smelter.
- Geist will document our efforts to trace tin, tantalum, tungsten, and gold minerals back to the smelter and will accurately report the results to our customers.
- Geist will continue to monitor industry progress in identifying conflict-free smelters and will adjust corporate policy as the electronics supply chain becomes more fully documented.

Geist will not require that our direct suppliers source only conflict-free minerals until an adequate number of smelters has been reliably identified and audited by The Electronic Industry Citizenship Coalition (EICC) and the Global e-Sustainability Initiative (GeSI) to service the electronic industry supply chain. Mandating a conflict-free supply chain before an adequate number of smelters has been identified will prohibit the use of all tin, tantalum, tungsten, and gold originating in the Democratic Republic of the Congo and surrounding countries. This prohibition would cut off the sole income source for many artisanal miners within the region and may result in increased violence within the Democratic Republic of the Congo in direct opposition to the goals of the Dodd-Frank Act. Geist will work continuously with our direct suppliers in order to annually increase the percentage of documented conflict-free minerals that are used in our products until all products can be certified as conflict-free.

Chapter 1: Installation


Click on the Device Director executable to begin installation (for example, DeviceDirector-4.7.0_setup_x64.exe).

Follow the onscreen prompts to accept the End User License Agreement (EULA), accept or change the install location and set shortcut options. Device Director will be installed according to the settings chosen.

Start Up


Once Device Director is installed, it can be started by clicking the icon in the Start menu or the Desktop (depending on user selected options during installation).

Device Director takes a few seconds to start, during which time the following screen provides progress updates.




Device Director should start without issue and display the home page.

If Device Director encounters a problem during start-up, an error will be displayed as shown below.

Figure 1-3 Device Director Start-Up Error Screen




On occasion, Device Director's backend start-up process does not start up quickly enough due to other processing that is temporarily consuming substantial resources on the computer; therefore, if the above error screen occurs, try starting Device Director again to resolve the issue. Another potential cause could be that the firewall on the machine is blocking access to port 9000, which is required for Device Director to function; if so, allowing access to this port

should solve the problem. If the issue remains after trying these recommended solutions, contact <u>Geist Support</u> for further assistance.

Chapter 2: Hardware Page

This table lists all hardware units known to Device Director. Hardware may be added, updated and deleted from this view.



Search by clicking the button at the upper right of the table opens a search dialog.




- o Items in the table can be searched by any combination of criteria. When search results are being displayed, the search button is green , indicating there are active search criteria.
- All search criteria can be quickly cleared by clicking Reset at the upper right of the search dialog. When all criteria have been reset, clicking Search will restore the table to showing all items, and the search button will return to its normal color.

- Columns: clicking the button at the upper right of the table opens a dialog for selecting which columns to show or hide.
- **Pagination:** item and page counts for the table are displayed at the bottom of the screen. While the number of items to show per page can be changed at the lower right of the screen, note that selecting to show a large number of items per page may slow down performance, depending on the capacity of the machine running Device Director.

Figure 2-3 Add Hardware Prompt: Choose how to add hardware




- **Geist Discovery**: discover uninitialized Geist hardware, usually with the intent of commissioning it, using a proprietary protocol.
- IP Address Scan: find hardware that has been assigned a valid IPv4 address (manually or via DHCP), that may or may not be fully commissioned. Found hardware can then be added to Device Director for management.
- **CSV Import**: add or update hardware using information from a spreadsheet. A CSV Import template can be obtained by exporting the current list of hardware (an empty template is exported if no hardware is in Device Director).

Geist Discovery

Add hardware by Geist Discovery - step 1 of 5: discovery settings

Figure 2-4 Geist Discovery Tool




- Hardware Models to Discover: select the types of hardware that should be discovered.
- Broadcast Settings: select how the discovery broadcast will be issued.
 Only one network card should be enabled on the machine running Device Director when the broadcast is made, and switches within the network must be configured to allow broadcasts through.
 - O IPv6 Multicast: allows the broadcast to be made without having to set the machine running Device Director to be on the same IPv4 subnet as the hardware to be discovered. Note that this does require the network card of the machine running Device Director to be enabled for IPv6 and configured for DNS.
 - Target IPv4 Addresses: should be set to the subnet broadcast of the hardware to discover (typically 192.168.123.255 for factory default hardware). Note that the

- machine running Device Director must also be assigned an IPv4 address on this subnet.
- Target MAC Addresses: one MAC address or a comma-separated list of MAC Addresses to be targeted by the discovery. This field may be used to limit which hardware units respond to the broadcast.
- o **Timeout**: sets how long to wait for responses after the broadcast is made.

Add hardware by Geist Discovery - step 2 of 5: select from discovery results





Possible hardware states illustrated in the table above:

- Row 1 no admin exists, DHCP on but no lease.
- Row 2 no admin exists, DHCP off, static IP is factory default.
- Row 3 admin exists. DHCP on but no lease.
- Row 4 admin exists, DHCP off, static IP is factory default.
- Row 5 admin exists, DHCP off, no static IPs.

Units displayed with an exclamation point instead of a checkbox (rows 3-5 above) cannot be initialized using Device Director. These units are in a state that requires a full factory reset before they can be initialized.

Select the hardware items to initialize and click **Initialize Selected Items**.

Figure 2-6 Initialize Hardware IPv4 Addressing Screen




It is possible to assign IPv4 addresses statically or using DHCP.

- **Start**: the first IP address in the range of addresses to use for assigning to discovered hardware units.
- **Increment**: used to calculate the next IP address to assign, from the start address and each subsequent address, until units are all addressed or the address space is exhausted (e.g. increment 1 indicates normal integer counting, increment 2 indicates skipping every other address).
- **Prefix**: the IP addressing prefix to set on the hardware, using CIDR notation (e.g. a prefix of 24 is equivalent to a subnet mask of 255.255.255.0).
- **Gateway**: the default network gateway to set on the hardware.

Add hardware by Geist Discovery - step 4 of 5: create admin account


Figure 2-7 Initialize Hardware IPv4 Addressing Create Admin Account Screen



- **Username**: username of the admin account to be set. Username must start with a letter and contain only letters and numbers (e.g. no hyphen, underscore, space or other special characters are allowed).
- Password: the password of the admin account to be set.
- **Verify Password**: ensures the password is entered as intended.

Add hardware by Geist Discovery - step 5 of 5: confirm initialization settings and add to Device Director

Figure 2-8 Confirm Initialization Settings Screen




Verify settings are correct.

Click **Initialize** and **Add** to initialize the selected hardware with the settings shown and add the hardware to Device Director.

If Geist Discovery was originally done via IPv4 broadcast to a subnet that is different from the subnet of the new IPv4 addresses being assigned to the hardware, Device Director will likely lose contact with the hardware once the new IPv4 addresses are set on the hardware. If this happens, Device Director will be unable to create an admin account on the hardware, and the initialization will appear to have failed. The process will have to be completed by reconfiguring the machine running Device Director to have network access to the subnet of the newly assigned IPv4 addresses, finding the newly addressed hardware by an IPv4 address scan, and then adding the found hardware to Device Director.

IPv4 Address Scan

Add hardware by IPv4 address scan - step 1 of 2: scan settings

• Target IPv4 Addresses: a comma separated list with no spaces (e.g., '10.0.0.2,10.0.0.3') or a range of IP addresses (e.g., '10.0.0.2-10.0.0.254').

- Admin Credentials: the admin username and password used to log into a hardware unit expected to be found in the given IP address range.
- Advanced Settings: the connection settings Device Director will use to communicate with hardware found in the IP address range being scanned. If the hardware to be found has settings that differ from these defaults, the appropriate connection settings must be entered here in order for the scan to succeed.
 - Network Protocol: the protocol to use for communicating with hardware units in the given IP address range.
 - o **HTTP Port**: the HTTP port to use for communicating with hardware units in the given IP address range.
 - HTTPS Port: the HTTPS port to use for communicating with hardware units in the given IP address range.
 - SNMP Port: the SNMP port to use for communicating with hardware units in the given IP address range.
 - SNMP Version: the SNMP version to use for communicating with hardware units in the given IP address range.
 - Read Community: the read community string expected to be on the hardware units in the given IP address range.

Add hardware by IPv4 address scan - step 2 of 2: select from scan results

Possible hardware states shown in the table above:

- Row 1 no admin exists, DHCP on and has acquired lease. Note that if a unit in this
 state is added to Device Director, an admin account will be created on the hardware
 using the credentials entered in the previous step.
- Row 2 admin exists, user entered valid admin credentials, DHCP on and has acquired lease.
- Row 3 admin exists, user entered valid admin credentials, DHCP off, main static IP address is not factory default.
- Row 4 admin exists, user entered invalid login credentials (i.e., no such user is on the hardware).
- Row 5 admin exists, user entered non-admin credentials (i.e., matched user on the hardware, but that user has no admin permissions.

Units listed with an exclamation point instead of a checkbox (rows 4 and 5 above) cannot be added to Device Director because the admin credentials entered for the scan did not match an admin account on the hardware.

Select the hardware items to add and click **Add Selected Items**. Hardware added to Device Director that does not have an admin account set will be updated with an admin account matching the IP Address Scan search criteria so that is can be properly administered.

Manual Device Add


A separate mechanism is not needed for manually adding a single hardware unit to Device Director. To add a single hardware unit, use either Geist Discovery or IP Address Scan and enter the specific search IP Address or MAC Address on the search settings page. If the hardware unit is found according to the settings entered, it can be added to Device Director.

Configure

Configure is used to update hardware settings, either individually or in bulk.

The Configure wizard separates updates into (1) choosing what to change and (2) changing the values. This is done to make clear what is being changed and to avoid the ambiguity of leaving a field empty for bulk updates. If a setting is selected for editing, it will be updated. Likewise, if a field is not selected for editing, it will not be updated. If a text field is selected for editing and its value is left blank, that field will be set to blank on all selected hardware. Boolean, integer and enumerated fields that are selected for editing must have a valid value set. To leave a field unchanged, do not select that field for editing.

- Network: configure chaining (for RSTP), HTTP/HTTPS ports, and DNS servers.
 - If only one hardware unit has been selected, there is also the option to edit its IPv4 address under network settings.
 - To batch-edit the IPv4 addresses of multiple hardware units, CSV import is recommended.
- User Accounts: add, edit, or delete user accounts.
- **SNMP**: configure SNMP port, security settings, and trap targets.
- Localization: configure language and temperature units.
- Email Alerts: configure SMTP settings and targets for email alerts.
- Remote Syslog: configure remote syslog.
- Firmware Update: update firmware on the hardware.
- Admin: edit system label, description, location, and admin contact.
- **Reboot/Reset**: reboot or restore factory settings on the hardware.

Figure 2-12 Network Settings Screen: select settings to edit





Figure 2-13 Configure Network Settings: edit settings



- Chain: assigns hardware to a particular network daisy chain. This setting is intended
 for networks using RSTP, in which units linked in the same network daisy chain can
 only be updated one at a time.
- HTTP Enable/Disable: enable/disable HTTP on the hardware.
- **HTTP Port**: HTTP Port to use on the hardware.
- HTTPS Port: HTTPS Port to use on the hardware.
- **DNS Server 1**: primary DNS server the hardware will use.
- DNS Server 2: secondary DNS server the hardware will use.

Note that if only one hardware unit has been selected, there is also the option to edit its IPv4 address under network settings.

Figure 2-14 Select which Settings to Update (IPv4 address selectable to edit if only 1 item selected)





Figure 2-15 Edit Network Settings (IPv4 address editable if only 1 item selected)



If switching between DHCP and static IPv4 addressing, the system will use IPv6 to maintain a connection with the hardware while the switch is made. Note that this requires the network card of the machine running Device Director to be enabled for IPv6.

In order to batch-edit the IPv4 addresses of multiple items, CSV import is recommended.

Figure 2-16 Select Type of User Account






Figure 2-17 Add User Account



- **Username**: username of user account to add. Can contain only letters and numbers (no spaces, dashes, or any other special characters), and the first character must be a letter.
- Password: password of user account to add.
- **Verify Password**: ensures the password is entered as intended.
- User Type: type of user account to add.

If the username entered already exists on a selected hardware unit, the add job will fail for that unit (i.e., indicating that an additional user account with that username could not be added to the hardware).

• **Username**: username of user account to delete from hardware.

If the username entered does not exist on a selected hardware unit, the delete job will fail for that unit (i.e., indicating that user account could not be deleted from the hardware).

Figure 2-19 Edit User Account: enter username of account to edit





Figure 2-20 Edit User Account: select account settings to edit

- Username: username of user account to edit.
- Password: new password for user account.
- **Verify Password**: ensures the password is entered as intended.





Figure 2-23 Edit SNMP Settings



- Port: SNMP port to use on the hardware.
- v1/2c Enable/Disable: enable/disable SNMP v1/2c on the hardware.
- v1/2c Read Community: v1/2c read community string to use on the hardware.
- v1/2c Write Community: v1/2c write community string to use on the hardware.
- **v1/2c Trap Community**: v1/2c trap community string to use on the hardware.

- **v3** Enable/Disable: enable/disable SNMP v3 on the hardware.
- v3 Read User, Auth, Privacy: v3 read username, auth scheme and password, privacy scheme and password to use on the hardware.
- v3 Write User, Auth, Privacy: v3 write username, auth scheme and password, privacy scheme and password to use on the hardware.
- v3 Trap User, Auth, Privacy: v3 trap username, auth scheme and password, privacy scheme and password to use on the hardware.
- Trap Target 1 IP Address, Version: address to which to send traps, version of trap.
- Trap Target 2 IP Address, Version: additional address to which to send trap, version
 of trap.

For Geist Upgradeable v1 PDUs and Watchdog 15/100 environmental monitors, older firmware versions (3.1.0 and earlier) do not support enabling/disabling SNMP v1/2c and SNMP v3 independently of each other. For hardware still running this older firmware, all versions of SNMP must be enabled/disabled together, or else the job will fail.

Figure 2-24 Configure Localization: select settings to edit





Figure 2-25 Edit Localization Settings: edit settings



- Language: language to show on the hardware interface.
- **Temp Units**: temperature units to show on the hardware interface.

Figure 2-26 Configure Email Alerts: select settings to edit





Figure 2-27 Edit Email Alert Settings



- SMTP Server: IPv4/v6 address or FQDN of the email server for the hardware to use.
- **SMTP Port**: port on the email server port for hardware to use.
- SMTP Auth Username: username to log into email server (leave blank if not required).
- SMTP Auth Password: password to log into email server (leave blank if not required).
- "From" Address: email address that alerts are to be shown as sent from.
- **Targets**: comma-separated list of destination email address(es) to add or delete from hardware.

Figure 2-28 Configure Remote Syslog: select settings to edit






Figure 2-29 Edit Remote Syslog Settings



- Remote Syslog Enable/Disable: enable/disable copying local hardware syslog to a remote location.
- IP Address: IPv4/IPv6 address of remote syslog.
- Port: port to use for remote syslog.

- Select File to Install: select the firmware file to use to update hardware.
- **Upload File**: upload a firmware file to Device Director for use in updating firmware on hardware.

Figure 2-31 Configure Admin Information: select settings to edit






Figure 2-32 Edit Configure Admin Settings



- **System Label**: free-text label for the hardware. Can be used as friendly name to help identify the hardware.
 - Append incrementing number: this option appears if two or more items have been selected. If checked, the text entered in the System Label field will be suffixed with a number, starting with 1 and incremented by 1, for each item selected. This provides a quick way to assign unique System Labels to many items at once.
- **Description**: free-text description of the hardware.
- **Location Detail**: free-text location details of the hardware.
- Administrator Name: contact info for the administrator of the hardware.
- Administrator Email: contact info for the administrator of the hardware.
- Administrator Phone: contact info for the administrator of the hardware.

Reboot/Reset

- Reboot: reboot the hardware.
- Reset all settings to factory defaults EXCEPT network configuration and user
 accounts: restore factory default hardware configuration except for network settings
 (e.g., IPv4 address) and user accounts. Occasionally, if the hardware takes longer
 than expected to finish this type of reset, the information stored in Device Director may
 fall out of sync with the actual hardware. It is recommended to Refresh hardware in
 Device Director after this type of reset appears to be completed.
- Reset ALL settings to factory defaults: restore full factory default hardware configuration.

Note that this will also delete the hardware from Device Director, since this will return the hardware to its uninitialized state.

Refresh

Refresh scans current settings on actual hardware and refreshes information stored in Device Director accordingly.

Delete

Delete removes hardware from Device Director. If the hardware remains online, it can be found again and re-added.

CSV Import/Export

CSV import may be used both to add hardware to Device Director and to update hardware already in Device Director. While it is possible to add some hardware and update other hardware in a single CSV import, it is recommended to do adds and updates with separate CSV files for manageability.

CSV export may be used to generate a template file that can simply be edited for import. An empty template is exported if no hardware has been added to Device Director yet.

Important considerations for CSV import:

- A device record will be added or updated in Device Director for each row of the CSV file.
- Missing device records (rows) in the imported file have no effect. Hardware known to Device Director will neither be deleted nor updated if it is missing from the CSV import. This is to allow for partial updates of only relevant hardware.
- Column headers present in the import file must exactly match the CSV template column names and must not appear more than once in the same file.

Adding Hardware with CSV Import

If a CSV row contains a MAC Address that is new to Device Director, or if the MAC Address is blank and the IPv4 Address is new to Device Director, the system will attempt to contact and add the hardware.

To add hardware to Device Director, the CSV row must include at minimum an IPv4 address and valid admin credentials in the User Accounts column.

The following defaults will be used to try to contact the hardware:

HTTP Port: 80

HTTPS Port: 443

SNMP Port: 161

SNMP Version: v2c

• v2c Read Community: public

If the hardware has settings that differ from these defaults, the appropriate connection settings must be included in the CSV import in order for the job to succeed.

Any additional settings that may be specified in the CSV row will be ignored in an add.

Updating Hardware with CSV Import

If a CSV row contains a MAC Address that is known to Device Director, the system will attempt to update the hardware as specified in the CSV.

When updating hardware, the MAC Address is the only required field; any other fields (columns) included in the CSV will be read as intended updates.

- Text fields may be blank, in which case the empty value is treated as the desired value. Boolean, integer and enumerated fields will be ignored if empty.
- Password fields that contain only * characters will be ignored.
- Missing columns in the imported file will have no effect. Hardware fields will not be updated with a blank value if a column is missing. This is to allow for partial updates of only particular fields of interest.
- Extra columns in the import file that are unknown to Device Director will be ignored.

CSV Fields (Columns)

See the user manual for a specific hardware model for more information on fields and their values.

- **MAC Address**: considered the unique identifier for correlating each CSV row to a hardware unit known to Device Director or for adding a new hardware unit if not already known.
- **IPv4 Address**: IPv4 address set on the hardware.
- **DHCP Enabled**: valid values are "TRUE" or "FALSE". If "FALSE", the IPv4 Address is static.
 - If switching between DHCP and static IPv4 addressing, the system will use IPv6 to maintain a connection with the hardware while the switch is made. Note that this requires the network card of the machine running Device Director to be enabled for IPv6.
- **IPv4 Prefix**: CIDR network prefix set on the hardware.
- **IPv4 Gateway**: IPv4 network gateway set on the hardware.
- *IPv6 Address: IPv6 address of the hardware.
- Chain: assigns hardware to a particular network daisy chain (leave blank if not required). This setting is intended for networks using RSTP, in which units linked in the same network daisy chain can only be updated one at a time.


- HTTP Enabled: valid values are "TRUE" or "FALSE".
- HTTP Port: what HTTP port the hardware is set to use.
- HTTPS Port: what HTTPS port the hardware is set to use.
- **DNS Server 1**: IPv4 address of the primary DNS Server that the hardware will use.
- DNS Server 2: IPv4 address of the secondary DNS Server that the hardware will use.
- User Accounts: user accounts on the hardware. Format of this field is Username; Password; IsEnabled; IsAdmin; IsControl. Users are separated by "&". Passwords are imported if included, but export shows ***** for security reasons.
 - When adding hardware to Device Director by CSV import, this field only needs to contain Username; Password;;; for one admin account on the hardware. This is required to verify admin access to the hardware. If the hardware does not yet have an admin set, an admin account with these credentials will be created.
 - When updating hardware already in Device Director by CSV import, the contents of this field fully "replaces" the accounts set on the hardware. E.g., to delete a user account on the hardware, all accounts except the one to delete should be listed in this field. To add a user account to the hardware, all existing accounts should be listed in this field, plus the account to add.
 - When exporting a CSV from Device Director, all existing user accounts on the hardware are exported in this field.
- **SNMP Port**: the SNMP port on the hardware.
- **SNMP Version**: the SNMP version for Device Director to use when connecting to the hardware. Valid values are "V1", "V2C", or "V3".
- SNMP v1v2c Enabled: valid values are "TRUE" or "FALSE".
 - For Geist Upgradeable v1 PDUs and Watchdog 15/100 environmental monitors, firmware versions 3.1.0 and earlier do not support enabling/disabling SNMP v1/2c and SNMP v3 independently of each other. For hardware still running this older firmware, all versions of SNMP must be enabled/disabled together, or else the job will fail.
- v1v2c Read Community: SNMP v1/2c read community string set on the hardware.
- v1v2c Write Community: SNMP v1/2c write community string set on the hardware.
- v1v2c Trap Community: SNMP v1/2c trap community string set on the hardware.
- SNMP v3 Enabled: valid values are "TRUE" or "FALSE".

- For Geist Upgradeable v1 PDUs and Watchdog 15/100 environmental monitors, firmware versions 3.1.0 and earlier do not support enabling/disabling SNMP v1/2c and SNMP v3 independently of each other. For hardware still running this older firmware, all versions of SNMP must be enabled/disabled together, or else the job will fail.
- **v3 Read User**: the SNMP v3 read user account set on the hardware. Format of this field is Username;AuthProtocol;AuthPassword;PrivacyProtocol;PrivacyPassword. Passwords are imported if included but export shows ***** for security reasons. AuthProtocol may be "NONE", "MD5" or "SHA1". If AuthProtocol is not "NONE", AuthPassword and PrivacyProtocol are required. PrivacyProtocol may be "NONE", "AES128" or "DES". If PrivacyProtocol is not "NONE", PrivacyPassword is required.
- **v3 Write User**: the SNMP v3 write user account set on the hardware. Format of this field is Username; AuthProtocol; AuthPassword; PrivacyProtocol; PrivacyPassword. Passwords are imported if included but export shows ***** for security reasons. AuthProtocol may be "NONE", "MD5" or "SHA1". If AuthProtocol is not "NONE", AuthPassword and PrivacyProtocol are required. PrivacyProtocol may be "NONE", "AES128" or "DES". If PrivacyProtocol is not "NONE", PrivacyPassword is required.
- v3 Trap User: the SNMP v3 trap user account set on the hardware. Format of this field is Username; AuthProtocol; AuthPassword; PrivacyProtocol; PrivacyPassword. Passwords are imported if included but export shows ***** for security reasons. AuthProtocol may be "NONE", "MD5" or "SHA1". If AuthProtocol is not "NONE", AuthPassword and PrivacyProtocol are required. PrivacyProtocol may be "NONE", "AES128" or "DES". If PrivacyProtocol is not "NONE", PrivacyPassword is required.
- **SNMP Trap Target 1**: primary SNMP trap target set on the hardware. Format of this field is lpAddress; Version. If IPAddress is set, Version is required. Version may be "V1", "V2C" or "V3".
- **SNMP Trap Target 2**: secondary SNMP trap target set on the hardware. Format of this field is lpAddress; Version. If IPAddress is set, Version is required. Version may be "V1", "V2C" or "V3".
- Language: the system language set on the hardware. Language uses the ISO Language Code and may be "de", "en", "es", "fr", "ja", "ko", "pt", "ru" or "zh".
- **Temp Units**: the temperature units set on the hardware. Valid values are "Fahrenheit" or "Celsius".
- **SMTP Server**: IPv4/v6 or FQDN of SMTP server through which the hardware is to send email.
- **SMTP Port**: TCP port to use on the SMTP server.
- SMTP Username: username for logging into SMTP server (leave blank if not required).

- **SMTP Password**: password for logging into SMTP server (leave blank if not required). Note that passwords are imported if included but export shows ***** for security reasons.
- **Email From Address**: email address that alerts from the hardware are to be shown as sent from.
- **Email Targets**: comma-separated list of destination email addresses to which hardware will send alerts.
 - When updating hardware by CSV import, the contents of this field fully "replaces" the list of email targets set on the hardware. E.g., to delete a target on the hardware, all targets except the one to delete should be listed in this field. To add a target, all existing targets should be listed in this field, plus the target to add.
- Remote Syslog Enabled: valid values are "TRUE" or "FALSE".
- Remote Syslog IP Address: the remote syslog IP address set on the hardware.
- Remote Syslog Port: the remote syslog port set on the hardware.
- *Firmware Version: version of firmware running on the hardware.
- **System Label**: free-text label for the hardware. Can be used as a friendly name to help identify the hardware.
- **Description**: free-text description of the hardware.
- **Location Detail**: free-text location details of the hardware. Typically a low-level detail of where the hardware is located (e.g. a floorplan grid or internal identifier).
- Admin Name: contact info for the administrator of the hardware.
- Admin Email: contact info for the administrator of the hardware.
- Admin Phone: contact info for the administrator of the hardware.
- *Model Name: commonly used description of the hardware model.
- *Model Number: factory designation for the exact specifications of the hardware.
- *Serial Number: serial number of the hardware.

^{* =} Field is considered read-only and exported for informational purposes. On CSV import, this field may be updated to something other than what is defined in the import file if the hardware reports a different value.

Chapter 3: Job Status Page



This page lists all job batches pending, in progress, or completed by Device Director. Batches are queued and processed in chronological order, but they are displayed in reverse chronological order, with the most recently created batch listed first.

Only one batch is processed at a time, to prevent potentially conflicting updates contained in different batches from coinciding on any hardware unit.

- Pending batches are collapsed by default but can be expanded to show their details.
 - o **Cancel**: cancels the pending batch of jobs. The batch will retain its place in the list but will be marked as Cancelled and can be cleared.
- If a batch is in progress, its details are expanded by default and updated as the batch progresses.

- o **Terminate**: stops all in-progress jobs within the batch immediately and cancels any pending jobs within the batch.
- o **Graceful Stop**: allows all in-progress jobs within the batch to complete and cancels any pending jobs within the batch.
- Completed batches are collapsed by default but can be expanded to show their details. Each completed batch is summarized by one of four labels:
 - o Successful: all jobs in the batch were completed successfully.
 - o Cancelled: all jobs in the batch were cancelled.
 - o Failed: all jobs in the batch failed.
 - Complete: some jobs in the batch succeeded, and some were either cancelled or failed. The number of cancellations and/or failures is shown in parentheses.
- **Clear**: removes a completed batch from the Job Status page.
